

Official Rules

No Purchase Necessary to Enter or Win. Purchasing Will Not Increase Your Odds of Winning.

PIN-Based Debit & International Transactions Not Eligible For Automatic Entry.

Failure to denote a Participating Issuer Financial Institution Name or any other requirement (as described above) on the outer mailing envelope will result in disqualification.** There is no limit on the number of entries an eligible consumer may receive during the Promo Period, regardless of entry method. No photocopied, computer generated facsimiles, mechanically reproduced, or mass entries permitted. All entries become property of Sponsor & will not be returned.
